

# **Policies and Regulations**

- Policy is a <u>basic statement of the intent</u> of the School Board which creates rights and responsibilities for the conduct of the school division's business. Policies are adopted by the Board.
- Regulation is the manner or <u>method of implementation</u> of policy by the Superintendent and staff, subject to change as conditions and/or circumstances may dictate. Regulations are approved by the Superintendent.

## **Standard Changes**

Standard Changes used on all policies and regulations

- Remove gender affirming terms
- Replace parent with parent/guardian
- · Reduce the use of 'shall' per VSBA model policy changes
- Add breadcrumbs to other policies
- Reword and reformat to improve readability
- Relocate definitions to the beginning

#### **BBA - School Board Powers and Duties**

- Code change
- Added definitions
- Clarified that the policy does not reflect all Board duties
- Changed the title as the policy does not list powers, only duties
- Policy updated to reflect amendment of Va. Code § 22.1-79 by
  - HB 1630/SB 1479. Reduces the required break in service for retiree-rehires to return to work while retaining their VRS pension
  - HB 2021. Requires each school board to ensure that at any back to school night event in the
    local school division to which the parents of enrolled students are invited, any such parent in
    attendance receives prominent notification of and access, in paper or electronic form, or
    both, to information about application and eligibility for free or reduced price meals for
    students and a fillable free or reduced price meals application that may be completed and
    submitted on site.
  - <u>HB 2025.</u> Requires ACPS to send home SNAP information and fillable applications every year
  - <u>HB 2161</u> and SB 1151. Standardizes the times for meeting notifications

#### BDDH-R - Procedures for Public Communications with the School Board (also KD-R)

- Update requested by the Board
- Updated to reflect that Board Retreats are open to the public



JEC - School Admissions
JEC-R - School Admission Regulations
JEC-R2 - Kindergarten and Grade One Placements

- Requested review
- Code change
- VSBA model policy alignment
- Struck language around kinship care that went beyond the code
- Struck language about students leaving during the school year, the topic is part of JC/JCD
- Removed the forms from the regulation. This permits ACPS to begin transitioning to an annual verification process for families living in shared housing (in alignment with Arlington and Fairfax) Clarified the process about placements of students who are age six but did not complete a kindergarten program
- Policy updated to reflect enactment of Va. Code §§ 22.1-369, 22.1-370, and 22.1-373 by HB 1929.
  - Establishes certain rights and privileges for any school-age child who is a dependent
    of a foreign service employee or civilian member of the Armed Forces of the United
    States under federal orders which results in the student's relocation from another
    state to a school division in the Commonwealth, including rights and privileges
    relating to educational records, enrollment, placement, attendance, extracurricular
    activities, and graduation.

JHCF-R2 - School Health Guidelines - Managing Allergies in Schools

- Requested review
- Standard Changes
- Removed general illness guidelines
- Removed COVID-19 guidelines from the regulation
- Transitioned JHCF-R2 from a regulation to a publication
- Replaced content that was redundant with Policy IGAE/IGAF Health / Physical Education with breadcrumbs to the policy

JHCF-R - Wellness Guidelines for ACPS
JHCF-R2 - School Health Guidelines - Managing Allergies in Schools

- Aligned the policy with the <u>VDOE Wellness Policy Guidance</u> (Wellness Policy Checklist, Model Wellness Policy, Wellness Policy Template)
  - Refined the Goals to align with the goals in the guidance
  - Added the role of SHAB
  - Added breadcrumbs to show where nutrition standards are in ACPS policy
  - Added roles and a process to implement the policy
  - Added a Triennial Assessment section
  - Added Public Involvement
  - Added Recordkeeping



#### **KBA-E - Rights and Responsibilities**

- Code Change
- Updated to reflect amendment of Va. Code § 2.2-3704.1 by <u>HB 2007</u>.
  - Requires a public body to make available upon request and post on its website or
    otherwise publish a written policy (i) explaining how the public body assesses charges
    for accessing or searching for requested records and (ii) noting the current fee
    charged, if any, by the public body for accessing and searching for the requested
    records.



### **Revision of School Board Policies**

### **Target**

The ACPS Board will review for equity and adopt at least 100 policies during the 2023-24 School Year.
