Mission

The objective of Alexandria City Public Schools strategic plan is to provide an equitable, high quality education which is accessible and engaging to all students in a five-year strategic plan approved by the Alexandria City School Board on June 26, 2020. The plan's mission is to ensure success by inspiring students and addressing barriers to learning. The Facilities and Operations Department (via the Office of Safety and Security Services) works diligently to remove a potential barrier, unsafe school environments, in an effort to further the strategic plan.

Overview

The Office of Safety and Security Services manages and oversees all safety-related services for the school division to include emergency management procedures and protocols, assignment of school security officers, hardened safety infrastructure and the school law enforcement partnership with Alexandria Police Department. This office also collects, reviews and reconciles data related to incidents on school campus grounds and/or school-sponsored activities. The purpose of this report is to present the data (founded and unfounded) for:

- School Incidents for specified quarter(s)
- Calls for Service/Assistance by APD data for specified quarter(s)

Data Submission and Collection Methodology

Safety data is submitted in the following ways:


- 1. *Incident Report:* School administrators will submit an Incident Report at the conclusion of an incident on school grounds.
- 2. *ACPS Calls for Service Form:* If the Alexandria Police Department is requested to assist during a school safety incident, the school administrator completes and submits this form to the Director of Safety and Security Services

Once an incident report is submitted, the Office of Safety and Security Services collects the data into a template. This template is updated regularly and captures division-level data to include number and types of incidents per school, per day and per month. <u>It is important to note that all information related to student discipline data is collected and reviewed by the Department of Student Services and Equity. That data is not included in this report.</u>

Information that may reveal student identity will not be shared through this report. It is also understood that some statistics may change as a result of change in case status or data error.




During quarters one and two of SY23-24, there were a total of **213** incidents that occurred. These incidents fell into the following categories:

- **95** incidents at the High School Level




APD Calls for Service

During quarters one and two of SY2023-24, there were a total of **118** APD Calls for Service.


By School Type

- **56** APD Calls for Service at the High School Level


APD Calls for Service: Semester Comparison



During quarters one and two of SY2023-24, there were a total of <u>118</u> calls for service, versus <u>137</u> calls for service for report two (Semester 2 SY2022-23), <u>96</u> calls for service for report one (Semester 1 SY2021-22), <u>84</u> calls for service for report two (Semester 2 SY 2021-22), and <u>74</u> incidents for report three (Semester 1 SY2022-23).

Arrests & Referrals


Monthly Summary



During quarters one and two of SY23-24, there were a total of thirty-one (31) student arrests and/or referrals. Arrests were made in regards to a violation of law on and off school grounds. Arrests were made in relation to the following categories:

- Assault (9) (8 On Campus Occurrences, 1 Off Campus Occurrence)
- Prohibited Item (Alcohol) (2) (2 On Campus Occurrences)
- Warrant (1) (On Campus Occurrence)
- Public Intoxication (4) (All On Campus Occurrences)
- Weapon (2) (2 Tasers) (All On Campus Occurrences.)
- Controlled Substance (7) (All On Campus Occurrences)
- Theft (5) (2 On Campus Occurrences, 3 Off Campus Occurrences)
- Vandalism (1) (On Campus Occurrence)


By School Type

During quarters one and two of SY23-24, there were a total of <u>31</u> arrests and/or referrals, versus **41** for report two (Semester 2 SY22-23), **20** arrests for report one (Semester 1 SY2021-22), **26** arrests for report two (Semester 2 SY 2021-22), and **17** arrests for report three (Semester 1 SY2022-23).
