Community & Staff Input

- Two meetings of the Calendar Committee on October 3 and November 14
- 2019-2020 Academic Calendar Online Feedback Forms were created for both Traditional and Modified calendars and posted on ACPS website
- Feedback was requested through ACPS Insider and ACPS Express.
- 460 responses were received (368 for the traditional calendar and 92 for the modified calendar)



Community & Staff Input

There were two sections to the public feedback form. The first section included draft versions of the 2019-2020 academic calendar with the following differences:

Version 1 closely follows the structure of the current year calendar and features eight week days off for Winter Break and a last day of school on Thursday, June 18.

Version 2 is similar to Version 1 in most respects, with two differences:

- 1. Winter Break instead of eight week days off, there is a full two week break.
- 2. The last day of school is Monday, June 22.

The second section sought feedback on the following year – 2020-2021 – and asked the following:

We are asking for feedback on a possible change in 2020-2021 to an academic calendar based on 990 hours instead of 183 days. The result would be a reduction in the number of student days and an increase in the number of professional development/teacher work days.



460 total responses were received with the following breakdown:

- Employee = 208
- Parent = 213
- Parent & Employee = 28
- Student = 6
- Community Member = 5
- Additional comments related to Version 1 versus Version 2 = 127
- Additional Comments related to hours versus days = 100

Key Features of Calendars

- 183 student instructional days
- The first day of school is September 3, 2019 for traditional calendar schools and August 1, 2019 for the modified calendar. The last day of school on both calendars is June 22, 2020.
- The Wednesday before Thanksgiving remains a holiday and the length of Winter Break is two weeks.
- Professional Development days are on August 28, 2019, October 14, 2019 and March 3, 2020.
- Columbus Day is a professional development day on the traditional calendar.
- Veterans' Day is a holiday on both calendars
- The first 3 snow days will not be made-up. Additional make-up days, if needed, will be as follows:
 - Traditional & Modified Calendars: April 13, June 23 and June 24
