SUMMARY:

The Department of Teaching, Learning, and Leadership's Office of Instructional Support has worked collaboratively with central office and school stakeholders to assess the professional learning needs to meet Virginia Department of Education requirements. In response to the training requirements outlined in the Virginia Literacy Act (VLA) it is necessary that school staff are allocated additional professional learning time. This dedicated time will ensure that school staff can thoroughly engage with and implement the required components, thereby enhancing their instructional practices and overall student outcomes.

DETAILS:

Due to the additional professional learning requirements, the following days have been recommended:

- 1st Quarter Wednesday, October 2, 2024
- 2nd Quarter Thursday October 31, 2024
- 3rd Quarter Tuesday, January 28, 2025
- 4th Quarter Wednesday, May 28, 2025

These dates are inclusive of the traditional academic calendar and modified calendar for Samuel Tucker Elementary School.

To support the effective implementation of these requirements, the Office of Instructional Support will collaborate to develop a comprehensive guidance document. This document will provide clear expectations and direction for school leaders, coaches, and teacher leaders regarding the in-persTon additional professional learning days.

For teachers who are not required to participate in the VLA training, these additional professional learning days will offer valuable opportunities for school-based professional learning and instructional planning through Professional Learning Communities (PLC). Suggested topics for these sessions include, but are not limited to:

- Planning for Project-Based Learning (PBL)
- Designing inquiry-based activities
- Differentiating instruction
- Planning for formative assessments

This focused planning time will enable teachers to enhance their instructional strategies, which will benefit students' learning experiences and outcomes.

BACKGROUND:

The Virginia Literacy Act (VLA) was enacted to ensure that all students develop strong literacy skills by the end of third grade. The act mandates specific training and instructional practices to support literacy development. Key components of the VLA include:

- Comprehensive training for educators on evidence-based literacy instruction
- Implementation of new literacy assessment tools and intervention strategies; and
- Regular monitoring and reporting of student progress in literacy.

These requirements are designed to improve teaching effectiveness and ensure compliance with the updates to state education and federal policy. By providing additional professional learning time, we can support our teachers in meeting these requirements and ultimately enhance the quality of education for our students.

BOARD BRIEF

RECOMMENDATION:

The Superintendent recommends that the School Board review the information in this brief and approve the recommended calendar change.

IMPACT:

Approving the calendar change will allow school staff with additional professional learning time to complete required state-mandated training.
