PLAYGROUND EQUIPMENT

When any playground equipment is installed on Alexandria City School Board property, the Board assumes ownership of that equipment unless specifically stated otherwise by agreement. For this reason, the maintenance of the playground equipment installed by a school will be the responsibility of the Board.

8 Once installed on Board property, the Alexandria City Public Schools (ACPS) will have the 9 responsibility to inspect the equipment on a regular basis, not less than annually, and the authority 10 to order its repair or removal from the school property if the equipment is unsafe in any way. The 11 ACPS Facilities and Operations Department may also restrict or deny the use of such equipment 12 until such time as it is restored to safe condition.
